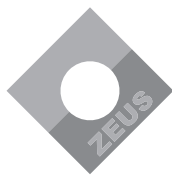

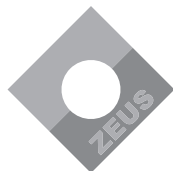

1. 收集閣下個人資料的原因
